LANCASTER FAIR HORSE SHOW WAIVER

"Every entry at a recognized show shall constitute an agreement and affirmation that the person making it, along with the owner, lessee, trainer, manager, agent, coach, driver, rider, and the horse: (1) shall be subject to the Constitution and rules of the Association and the local rules of the show; (2) that every horse, rider, and/or driver is eligible as entered; (3) that the owner and any of his representatives are bound by the Constitution and Rules of the NEHC, NHH&TA and the show will accept as final the decision of the hearing committee on any question arising under said rules and agree to hold the show, the NEHC, NHH&TA, their officials, directors and employees harmless for any action taken; (4) that the owner, rider/driver and any of their agents or representatives agree to hold the NEHC, NHH&TA, the show, and their officials, directors, employees and agents harmless for any injury or loss suffered during or in connection with the show, whether or not such injury or loss resulted, directly or indirectly, from the negligent acts or omissions of said officials, directors, employees or agents of the NEHC, NHH&TA or show." Management reserves the right to decline or refuse any entry without being liable for compensation, and eliminate from further competition any exhibitor or horse should the best interest of the show be served.

Every exhibitor or his agent and trainer must sign an entry blank. In the event of his failure to do so, his first entrance into the ring as an exhibitor shall be construed as his acceptance of the rules of the show involved and of the NEHC and shall ipso facto render him subject to said rules.

I agree that each foregoing reference to the "Competition" shall include the Lancaster Fair Association Horse Show and that "Loss" shall include "By Fire". I further agree to forfeit and pay to the Lancaster Fair Horse Show the sum of up to \$1,000.00 as and for liquidated damages, if the animal or any of the animals which I may exhibit are suffering from any contagious or infectious disease. I further agree to reimburse the Lancaster Fair Horse Show for any property damages that may occur.
